

## 2025 Fowlerville Family Fair Off Season Camping Application & Rules

1. Upon arrival, campers must check in with the Office Staff.
2. Site assignments will be given based on the size of the unit. No sites will be held without payment AND a camping application form.
3. **NO SWITCHING OF SITES** will be granted without authorization from office. Those who are found changing sites will be asked to leave and will not receive refund.
4. Each campsite will be required to have a responsible adult (age 18 or above) staying in the camper at night and their name listed on the application form for supervising younger members of the camping group. The names of all the members of the camping group shall be listed on the application and the name and phone number of the person or persons to contact in case of an emergency. This will be strictly enforced.
5. Campers are to be quiet after 11:00pm – **This will be strictly enforced.**
6. No illegal drugs will be allowed on the grounds.
7. No dumping of wastewater on the grounds except in the dumping station.
8. All water hoses and trailer connections **MUST** not leak. If this becomes a problem they will be disconnected by the campgrounds supervisor.
9. Electrical cords **MUST** be a 12 gauge or better with the proper ground.
10. Fire lanes are to be kept clear at all times.
11. Payment for monthly camping will be due on the first of the month preceding the stay. If arriving mid month the amount will be prorated and will be due upon arrival.
12. **If you have animals (pets) you are responsible for clean-up. The animal MUST be kept quiet (if possible) and at your site unless on a leash with you. During events, animals (pets) are NOT allowed in public areas. MUST be kept at campsite.**
13. Campfires must be kept contained. Please see office. Please provide your own wood and firepit/ring.
14. A maximum of six people will be allowed to stay at any one campsite.
15. **Any camper or member of a camping group who violates any of these rules will have their camper permit revoked. They will be required to leave the fairgrounds and remove their camper from the grounds or they will be removed. Camping fees will be forfeited, and no refunds will be made.**
16. Fowlerville Agricultural Society (“Fowlerville Family Fair”) will not be responsible for accidents or injury to any campers, guest, loss of money, food, beverage, or damage to property of any kind. All tenants will be responsible for the conduct of their guests including any damage done by the tenants or their guests and parents will be held responsible for any damage done by their children.
